Terms Of Business

The Payment Terms and Conditions stated below are for personalised and standard funerals. Other funeral options offered by us may have varying payment terms. Please go to our Funeral Costs section on our website to see all funeral options and their payment terms. Alternatively, if visiting our premises, ask for our full price list.

If you are considering making a Funeral Support Payment (FSP) claim, you must inform your funeral co-ordinator or funeral director at the time of the funeral arrangement. The FSP payment will not cover all funeral costs.

Deposits

For personalised and standard funerals, we require a deposit of £1,200 to be paid with 2 days of the confirmation of the funeral arrangements. This can be paid by cash, cheque, credit or debit card or bank transfer. If the funeral includes a burial and the burial plot is to be purchased by us, then we require all third-party costs to be paid in full within 2 days of the confirmation of the funeral arrangements. If a solicitor is taking responsibility for the funeral invoice there is no need for a deposit. However, we must receive written confirmation from the solicitor that they accept responsibility for the payment of our funeral invoice. We must receive confirmation from your solicitor within 2 working days from the arrangement. Our Payment Terms and Conditions must also be signed by the client.

If the solicitor is not in funds to pay the invoice within the agreed payment terms time frame the funeral invoice will revert to the client for immediate payment. Extension of the agreed payment terms will be considered if the request is in writing to the Managing Director of Porteous Funeral Directors stating the reason why you or your solicitor require the extension.

Payment

The funeral invoice will normally be sent 5-7 days after the funeral and is due within 28 days of the funeral date unless otherwise agreed by us in writing. Finance facilities are available, ask for details.

Interest

If the invoice remains unpaid beyond the due date, we reserve the right to charge a late payment penalty of £100. We also reserve the right to charge interest at £2 per day. The interest will accrue daily from the due date until the date of payment is actually paid on the overdue amount. We reserve the right to recover all legal and debt collection agency fees if you breach the terms of the agreement.
